Jakarta, November 9, 2023 – PT MD Pictures Tbk (FILM) has maintained its position as a market leader in the Indonesian entertainment industry through a content creation strategy that caters to the interests of the Indonesian market.

'Kisah Tanah Jawa: Pocong Gundul' Among the Highest-Grossing Films in Indonesian Cinemas in 2023 Two MD Pictures films topped the Indonesian film box office for January-September 2023. In April 2023, the movie 'Sewu Dino' was the most-watched Indonesian film, attracting 4,886,406 viewers. In September 2023, the horror movie 'Kisah Tanah Jawa: Pocong Gundul' was released, garnering 1,648,624 viewers. These achievements have enabled MD Pictures to capture a market share of 27% by the third quarter of 2023 with two blockbuster movies.



'MD Pictures' content has found success not only in cinemas but also on digital platforms'

As of the end of September 2023, MD Pictures had a total revenue of Rp 294 billion. Content sales contributed 93% to the total revenue, which is the company's core business. The revenue generated from digital content sales amounted to Rp 136 billion as of September 30, 2023, an increase of 161% compared to the same period in 2022, when it was Rp 52 billion. The sales contribution from digital channels has become equivalent to non-digital segments such as TV and Cinema.

"As part of its strategy to remain relevant with market dynamics, MD plans to expand its distribution channels to include OTT platforms. MD's content distributed on OTT platforms has proven highly popular locally and internationally. This move is expected to become a new growth engine for MD, and we are very optimistic about the bright prospects ahead." explained Manoj Punjabi.









MD Pictures' success in boosting revenue from the digital segment is inseparable from various series aired on leading digital platforms such as Disney+Hotstar, Prime Video, WeTV, and iflix, as well as Telkomsel MAXstream. Series like 'Induk Gajah' on Prime Video, 'Mozachiko' on WeTV Indonesia, 'Jurnal Risa' on Disney+Hotstar, as well as 'Princess and The Boss' on Telkomsel MAXstream, were watched by millions and topped the charts as the audience's most favored series.

'Thick Margins and Solid Cash Flow'

MD Pictures had a consistently strong financial performance throughout 2023. By the end of September 2023, their EBITDA had reached Rp 208 billion with an EBITDA margin of 71%. The EBITDA and margins improved since the year's second quarter, mainly due to the release of various films and blockbuster content. Additionally, MD Pictures maintained a strong cash flow with a *net cash* position of Rp 471 billion as of September 30, 2023.
