

# THE ADDITIONAL ANNOUNCEMENT OF THE PROPOSED CAPITAL INCREASE WITHOUT PRE-EMPTIVE RIGHTS ISSUANCE PT MD ENTERTAINMENT TBK

This announcement is made and implement in compliance with Article 43A of the the Financial Services Authority (*Otoritas Jasa Keuangan* or “**OJK**”) Regulation No. 14/POJK.04/2019 on Amendments to OJK Regulation No. 32/POJK.04/2015 on Capital Increase of Public Companies with Pre-emptive Rights (“**POJK 14/2019**”).

This announcement is important to be considered by the shareholders of PT MD Entertainment Tbk (the “**Company**”) and is an integral part of (i) the information disclosure in connection with the Capital Increase without Pre-emptive Rights (“**Capital Increase**”) which has been announced by the Company on 28 August 2024 and 4 October 2024 as well as (ii) the Additional Announcement of the Proposed Capital Increase Without Pre-Emptive Rights Issuance which has been announced by the Company on 1 November 2024.

The Company hereby announces that the Company will carry out a Capital Increase with the purpose of other than to improve its financial position as referred to in Article 3 (b) of POJK 14/2019. The Capital Increase Plan has been approved by the Company's shareholders in the Extraordinary General Meeting of Shareholders held on 8 October 2024 and as stated in the Minutes of Extraordinary General Meeting of Shareholders No. 13 dated 8 October 2024, drawn up before Leolin Jayayanti, S.H., M.Kn. As part of the Capital Increase, the Company will issue new shares in the amount of 170,248,302 (one hundred seventy million two hundred forty eight thousand three hundred two) shares ("**New Shares**") with the following implementation schedule:

The New Shares will be fully subscribed by PT Samuel International.

In accordance with the provisions in the Indonesian Stock Exchange ("**IDX**") Regulation No. I-A on Amendments to Regulation No. I-A on the Listing of Shares and Equity Securities Other Than Shares Issued by Listed Companies, as attached to the Decree of the Board of Directors of the IDX No. Kep-00101/BEI/12-2021, dated 21 December 2021, considering that the Company is conducting a Capital Increase for the purpose of other than to improve its financial position, the execution price for the issuance of New Shares shall be at least 90% (ninety percent) of the average closing price of the Company's shares traded on the IDX for 25 (twenty-five) consecutive trading days in the regular market prior to the date of submission of the application for the additional share listing to the IDX. In this case, the execution price for the Capital Increase is Rp2,834 (two thousand eight hundred thirty four Rupiah) per share.

After the implementation of the Capital Increase, the number of issued and paid-up capital of the Company will increase from 9,727,539,660 shares, with a total nominal value of Rp972,753,966,000 to a total of 9,897,787,962 shares, with a total nominal value of Rp989,778,796,200.
