PT MD ENTERTAINMENT TBK ANNOUNCES RIGHTS ISSUE I (PMHMETD I); STRATEGIC INVESTOR SBS Co., Ltd. INVESTS APPROX. USD 20 MILLION

Jakarta, 26 June 2025 — PT MD Entertainment Tbk ("the Company"), a leading entertainment firm in Indonesia, today announced the implementation of its Rights Issue I ("PMHMETD I") as part of its strategy to strengthen its capital structure and support long-term business expansion.

Through this corporate action, the Company is issuing 989,778,796 new shares, expected to raise approximately IDR 791 billion. Every 10 existing shares entitle shareholders to receive 1 Right (HMETD).

A key highlight of this transaction is the substantial participation of SBS Co., Ltd., a prominent Korean media and entertainment company. Through a rights transfer from PT MD Corp Enterprises, SBS Co., Ltd. acquired 413.8 million HMETDs and has committed to exercising all of them. The total investment by SBS Co., Ltd. amounts to approximately around USD 20 million.

The President Director of the Company, Manoj Dhamoo Punjabi, has also confirmed his full participation in the rights offering—both directly and through additional purchases of HMETDs from PT MD Corp Enterprises. "The entry of SBS Co., Ltd. as a strategic investor not only bolsters our financial position but also unlocks valuable cross-border collaboration potential for our global expansion," Manoj stated.

Proceeds from PMHMETD I will be used for the following purposes:

- 1. Repayment of a loan to PT Bank Mandiri (Persero) Tbk totaling IDR 748.2 billion
- 2. Working capital needs, including film production and other operational expenses

This move is expected to reduce interest burden, improve financial ratios, and establish a strong foundation for the Company's growth initiatives amid the dynamic digital entertainment ecosystem.
