## MD Entertainment Gains Investor Confidence as Rights Issue Execution Reaches 96%

Jakarta, 23 July 2025 — PT MD Entertainment Tbk (IDX: FILM) announced the successful execution of its Rights Issue (PMHMETD I), achieving an impressive implementation rate of 96%. Meanwhile, for the remaining rights that were not exercised, shareholders submitted additional subscriptions with demand reaching 16 times the number of rights available.

CEO of MD Entertainment, Manoj Punjabi, stated, "The success of PMHMETD I is not only a financial achievement but also a strategic milestone in advancing global collaboration. SBS's support paves the way for Indonesian content to expand its reach to international audiences."

PMHMETD I raised IDR 791.82 billion, including a significant participation from SBS Co., Ltd, a leading broadcasting company based in South Korea. SBS invested USD 20 million through the transfer of rights from PT MD Corp Enterprises, strengthening cross-border cooperation in content development and market expansion.

President and CEO of SBS, Bang Moon Shin, commented, "This investment is part of our new growth strategy focused on enhancing international partnerships. The collaboration aims to reinforce our position in the Southeast Asian content market and further diversify SBS's global partnership portfolio."
